CALL ALERT: Public Workshops Being Held for Proposed Division Rules for Electronic Voting

July 22, 2015

Many of our CALL Members have already inquired about the new ability to conduct membership votes online. CALL will be disseminating information about the preferred mechanics for such voting in the coming weeks and months. In the interim, the Florida Department of Business and Professional Regulation (DBPR) will be holding two Rule Development Workshops which are open to the public on August 6 and August 7 to discuss proposed rules for Condominiums and Cooperatives to update the procedures governing elections regarding ineligible candidates and electronic voting procedures provided for in the recently enacted Chapter 2015-97, Laws of Florida. The DBPR will be seeking public feedback to assist in drafting these rules.

Both meetings will be held at the North Broward Regional Service Center, 1400 West Commercial Blvd., Ft. Lauderdale, FL 33309

The August 6th meeting will be held from 2:00 pm-4:00 pm and the August 7th meeting will be held from 9:00 am-11:00 am.

The rules will amend 61B-23.0021 and 61B-75.005 respectively. Additionally, the rules will add new rules (as 61B-23.00211 and

61B-75.0050 respectively) specifically titled
"Electronic Voting."

The text of the rules is not yet available.

rules which will govern the new online voting
procedures for association elections. It's
time to be part of history in the making!
